



**MEMORANDUM OF AGREEMENT

**On this day Wednesday dated 14 month November year two thousand twelve located in Chonburi, Thailand, we the undersigned below:**

- 1. Asst. Prof. Sub. Lt. Ekkawit Maneethorn, Ph.D** as Dean, Faculty of Political Science and Law, Burapha University, in this case acting for and on behalf of Faculty of Political Science and Law, Burapha University hereinafter called the FIRST PARTY.
- 2. Bambang Yunarko, SH., MH,** as Dean of Faculty of Law, Wijaya Kusuma Surabaya University, in this case acting for and on behalf of Faculty of Law, Wijaya Kusuma Surabaya University hereinafter called the SECOND PARTY.

The FIRST PARTY and the SECOND PARTY jointly declare agreed and agreed to create a cooperation agreement with the following conditions:

**Article 1**

**PURPOSE AND OBJECTIVES**

- (1) The purpose of this cooperation agreement for the implementation of the Memorandum of Understanding signed by The President of Burapha University with the Rector of Wijaya Kusuma Surabaya University;
- (2) The general objective of this cooperative agreement is to implement the Tri Dharma College and encourage increased research and education funded by the government of Indonesia (DIKTI) or funded by the Thailand government that some or all of their funds come from the state budget revenues and expenditures.
- (3) The specific objective is to improve the quality of human resources colleges that have the intellectual capacity of qualified and able to be applied in the life of the nation.

**Article 2**

**SCOPE OF ACTIVITIES**

These collaborative activities include:

- (a) The joint research, (b) Seminar / workshop, (c) The exchange student, (d) The internship program / internship, (e) Education and training of educational, (f) Lecture guest lecture, (g) Double degree program, (h) journal publications, (i) Flagship scholarship program, (j) Sending lecturers for graduate studies (S-3), and (k) Exchange of arts and cultural.

**Article 3**  
**IMPLEMENTATION OF ACTIVITIES**

First party and second party can form a team that is tasked to formulate a program of activities referred to in Article 2 of this memorandum of agreement for academic purposes.

**Article 4**  
**FINANCING**

All costs required for the implementation of cooperation activities comes from the budget of each party as well as other legitimate sources in accordance with the provisions of the legislation.

**Article 5**  
**DURATION**

Term of this agreement for 5 (five) years since signed by the parties and may be extended upon mutual agreement of the parties.

**Article 6**  
**CLOSING**

- (4) Agreement of cooperation was created in order 2 (two) each stamped original enough and have the same force of law when signed by both parties and stamped their respective institutions.
- (5) Things that are not regulated in the text of this Cooperation Agreement shall be governed and with the consent of both parties.
- (6) Cooperation agreement shall enter into force since signed with the proviso that if later on there was mistake will be corrected accordingly
